3) Shipment:

We discourage the use of EMS for sample shipment.

Product may reach us through the **CARGO MODE only** and not if shipped in courier mode.

Custom Office clearance procedure, whenever required will have to be followed by us. Our nominated custom clearance agent will do the needful on our behalf. This will attract additional fees (about 200 – 300 USD).

For this purpose following documents in English language, if already present with the shipment, can help to make the customs-clearing work faster.

1. **MSDS** or any published information on the toxic/other properties of the test item.
2. **COA** - Certificate of analysis / identity / purity of the test item.
3. a declaration that “the material is being shipped to INTOX Pvt. Ltd., Pune, India for research and testing purpose and is not for sale or trade. It has no commercial value”.
4. **INVOICE** (Not proforma invoice) mentioning the correct name of test item, quantity, realistic value declared (**declaring some price of the enclosed sample** so that the customs officer can charge some duty on the basis of the same e.g. 1 \$, 2 \$, 5\$ etc.). But this value should be realistic (not too high or too low). Mention BTN number (i.e. H. S. code) of the product. **Do not include the list of toxicity studies and their prices in such documents.**
5. Certificate of ‘dangerous goods,’ if applicable.

- b) Signed Project Contract, if any / Work Order letter etc.
- c) Certificate of Analysis for each Test Item : This should include (with all other particulars),
 - a. Batch No.
 - b. Date of Manufacture
 - c. Date of Expiry (specify the storage conditions)
 - d. Signature of the Chemist / Company's authorized officer / QC Head etc.
 - e. Printed with Seal of the company and / or on official Company letter-head.
